CUSICK MONTHLY REPORT OCTOBER 3, 2023

- POFD4 was dispatched to 43 calls in the month of September, with the breakdown being 21 in Newport
 City, 10 in the Newport area, 7 in Usk and 4 in Cusick. We were also dispatched to 1 mutual aid request,
 which was with Kalispel Fire at the casino. The break down for locations and call types are included
 below.
- All apparatus and personnel are back from the fire assignments across the region which we were sent. The District made over \$70,000 contracting out to the various agencies on those deployments.
- Fire District 4 had to pull out of the deal trying to acquire Pend Oreille Paramedics. The cost for personnel during the first few months was going to be to much of a burden while waiting for accounts payable to start rolling in at rates high enough to cover those expenses. Leaders from the various stakeholders are still meeting to try and find a viable solution.
- Camp fires and debris burning is now legal again.
- The High School has asked us to supervise a bonfire at the baseball field parking lot, which we will do so long as we are not tied up on any emergencies.
- Fire District 4 has received over \$150,000 dollars in grant money over the last couple of weeks. \$30k was given to us from Better Health Together to be able to purchase needed medical equipment and supplies, just under \$112K was from FEMA to reimburse us for costs related to COVID. The balance was from Washington Department of Health for participating in a state wide quality assurance analysis.
